I further understand that once accepted, my initiation fee does not grant me any proprietary rights or ownership in the Club, nor does my acceptance as a member guarantee future membership rights in the Club. All memberships in the Club are non-equity and non-proprietary memberships. All memberships are a minimum of a one-year commitment. Memberships do not imply any right or privilege to participate in or to administer the Club's business and policies. I further understand and agree that upon my acceptance for membership to the Club, I will abide by the Bylaws and all rules and regulations set forth by the Club and Cypress Creek. Under the conditions stated in the Bylaws, I understand and agree that my membership may not be transferred until all financial obligations of my membership are settled in full. The dues for all memberships and all other fees and prices are set at the sole discretion of the Club. In order to activate a house account and receive charging privileges, I agree to provide the Club with a valid credit card number as requested. I understand that the balance of my house charge account will be billed to my credit card for all charges unpaid for 30(thirty) days or more. If I choose not to activate a house account, I understand that in addition to my initiation fee, I may be required to pay a 3 (three) month security deposit for the amount of \$ _____, which will be refunded to me in full upon resignation or termination of my membership, only after I have met all the conditions to resign described in the Bylaws and only after any and all charges due by me are paid in full.

Each member can have a club statement emailed or mailed to them upon request. Dues and account charges are automatically charged on the 1st day of each month unless the author wise approved by a manager. If dues or charges are not payed within 15 days, then they are considered delinquent. A late fee and finance charges will be accessed to any and all accounts over 14 (fifteen) days late. Members whose charges remain delinquent for 60 (sixty) days or more will have their membership privileges suspended until the account is paid in full. If the account is paid in full within 30 (thirty) days of suspension, there is a \$50 reinstatement fee to reactivate my membership. If the account remains unpaid beyond 90 (ninety) days, the membership will be revoked with no eligibility to transfer the membership. If my membership is terminated for delinquency, and if collection of my account requires the assistance of attorneys or a collection agency, I (we) agree to pay the additional amount due on the account, reasonable attorney and court costs, as well as any initiation fees or dues owed. I further understand that I may resign from the Club following my first 12 (twelve) month commitment by giving 30 (thirty) days advanced written notice to the Club. Should I choose to resign prior to my first anniversary date, I agree to pay the remaining dues for the 12 (twelve) month period up to my first anniversary date, and all other charges for which I may be liable, and I shall not thereafter be subject to any further dues or charges. I hereby acknowledge that the use of the Club facilities and any privileges or service incident to Membership is undertaken with knowledge of risk of possible injury. I hereby accept any and all risk of injury to myself, my guests, and family sustained while using the Club facilities or involved in any event or activity incident to Membership at the Cypress Creek property.
